If you are interested in presenting a workshop session during one of the 2021 conferences, the **National Conference on Juvenile Justice in Dallas, TX, March 21- 24, 2021**, and/or the **84th Annual Conference in St. Louis, MO, July 18 - 21, 2021**, please submit your proposal by September 30, 2020.

Both conferences will offer a variety of sessions on cutting edge topics, current research, and innovative practices. We are looking for proposals on a broad range of topics, including but not limited to: system reform efforts; child abuse and neglect; family violence – teens, intimate partners, elders; juvenile justice; custody and parenting time; financial aspects of divorce; access to justice; domestic child sex trafficking; anti-shackling alternatives; racial and ethnic disparity; crossover youth; brain science, child development, mental health; juvenile and family drug treatment courts; trauma; detention alternatives; judicial leadership; ethics; wellness and self-care; implicit bias and decision making; children testifying in court; state and tribal court partnerships; and collaboration within court systems and among community stakeholders.

The National Conference on Juvenile Justice examines the issues facing courts and stakeholders in the juvenile justice system. The audience is multi-disciplinary, including judicial officers, juvenile probation staff, defense and prosecuting attorneys, detention staff, and direct service providers. The 84th Annual Conference is the annual meeting for the NCJFCJ membership. The audience is primarily juvenile and family court judges, court stakeholders, and community affiliates.
