

BUSINESS MEETING OF THE GENERAL MEMBERSHIP Tuesday, July 21, 2020 Virtual

MINUTES

Call to Order and Welcome

Judge Ramona Gonzalez, NCJFCJ President, called to order the NCJFCJ Business Meeting of the General Membership at 11:02 p.m. and welcomed everyone present.

Judge Gonzalez presented the registration of proxies, as follows: Judge Leonard Edwards, California – 1; Judge Faith Graham, Indiana – 10; and Judge David Katz, New Jersey – 102.

Judge Gonzalez announced the following appointment of Convention Officers:

Judge Gonzalez recognized Executive Committee members, Board Directors, Past Presidents, former Board Directors, and the NCJFCJ team. She announced that a copy of the meeting Agenda and exhibits can be accessed online.

President's Report

Judge Gonzalez drew attention to **Exhibit I**, three resolutions adopted by the Board of Directors over the previous year: Memorial Resolution for Judge Sheri Roberts, Memorial Resolution for Dean Louis McHardy, and Regarding Access to Medication-Assisted Treatment for Adolescents and Adults in the Juvenile Justice System. She also noted the NCJFCJ Executive Committee, with review by the Legislative Committee, supported the following: Juvenile Justice for Juveniles Act, Family First Transition Act, CONNECT Act, JJDPA FY2021 Funding, Byrne JAG and COPS Program, Increasing Opportunities for Former Foster Youth Act, NTF COVID-19 Stimulus Letter of Support, and the COVID-19 Stimulus Council of Nonprofits Letter of Support.

Judge Gonzalez presented the 2020 President's Award to Amy Saathoff, NCJFCJ Curriculum and Education Programming Manager, for her leadership and dedication to developing quality curriculum and education.

Treasurer's Report - Exhibit II

Judge Egan Walker, NCJFCJ Treasurer, outlined highlights of the past year, including the NCJFCJ's switch to a new bank, the Payroll Protection Program (PPP) loan, the switch to an unemployment private trust, and the completion of the audit on time and faster than the auditors had seen it in decades. He also shared the endowment fund remains healthy at \$2.1 million despite the challenges faced by COVID-19, and the NCJFCJ now has \$1.8 in temporarily restricted funds. Financial goals for the future include submitting an application for partial forgiveness of the PPP loan, and putting out an RFP for an assessment on the NCJFCJ's cyber security.

Membership Report – Exhibit III

Judge Barbara Mack, NCJFCJ Secretary, reported that as of July 1 we have over 1,819 members, and NCJFCJ employees will now be allowed to join the NCJFCJ as Associate

Members if they choose. She reported every new, current non-member, participant of the virtual 83rd Annual Conference is receiving one year of free membership as part of their registration fee.

Judge Mack announced a new annual conference tradition. She shared the NCJFCJ has loyal members dating back to 1973-1980, and the NCJFCJ would like to recognize the following long-term members: Judge Maurice Portley, Judge Thomas E. Hornsby, Judge Peter Sakai, and Judge Charles M. McGee. NCJFCJ logo jackets have been sent to these members in recognition of their dedication and commitment to the NCJFCJ. Judge Mack noted the NCJFCJ looks forward to celebrating the next four members after 1980 at the in person 84th Annual Conference in St. Louis, Missouri, in July 2021.

Action Items

Judge Mack brought forward **Exhibit IV**, the minutes of July 30, 2019 Business Meeting of the Members. A motion was made and a second received that the minutes be approved as presented. There was no discussion. **MOTION CARRIED**

Judge Mack presented **Exhibit V**, the ceremonial resolutions in appreciation of those who helped to make the 83rd Annual Conference a success.

 A motion was made and a second received to adopt Resolution No. 1. There was no discussion. MOTION CARRIED.

NCJFCJ Diversity Initiative

Judge Hiram Puig-Lugo acknowledged Judge Chris Wickham, Judge Juliette Scales, and Judge Susan Maven for their support and assistance with the NCJFCJ's Diversity Committee and Diversity, Equity, and Inclusion (DEI) efforts. He provided an overview of the DEI Collaborative and a recap of the inaugural Summit in 2019, and the 2nd Annual Summit held on Sunday, July 19, prior to the start of the NCJFCJ's annual conference. He acknowledged the collaborative partner organizations and members of the NCJFCJ team instrumental in the conversation. During the summit, the group identified two key projects: organizational resource sharing, and the development of a census video.

Nominating Committee Report

Judge Peter Sakai presented the slate of judicial director candidates proposed for election to a three-year term on the NCJFCJ Board of Directors.
