**ORDER TO ESTABLISH COMPLIANCE WITH PROTECTIVE ORDER  
PROHIBITING POSSESSION OF FIREARMS AND AMMUNITION  
OR SUSPENDING LICENSE TO CARRY**

**THE COURT FINDS** the Respondent is subject to a Protective Order which:

**Federal Violence Against Women Act**

Was issued after a hearing at which Respondent received actual notice and the opportunity to participate, and the order restrains Respondent from harassing, stalking, or threatening an intimate partner or child of a person or partner, from engaging in any conduct that would place the intimate partner in reasonable fear of bodily injury to the partner or child, and includes a finding Respondent represents a credible threat to the physical safety of such persons, or explicitly prohibits the use, attempted use, or threatened use of physical force against such persons that would reasonably be expected to cause bodily injury; Federal law prohibits possession, receipt, and transport of any firearm or ammunition.

**Texas Family Code Chapters 83 and 85**

Was issued pursuant to Chapter 83 or Chapter 85 of the Texas Family Code and may include prohibitions against Respondent from (1) committing family violence or an act in furtherance of family violence, (2) communicating (a) directly with a protected individual or a member of the family or household of such person in a threatening or harassing manner, (b) a threat through any person to a protected individual or that person's family member or member of the protected person's household, or (c) in any manner with the protected individual or that person's family member or member of the protected person's household except through the person's attorney or person appointed by the court, (3) going to or near the residence, place of employment or business, or child care facility or school of a protected person, or (5) harming, threatening, or interfering with the care, custody, or control of a pet, companion animal, or assistance animal possessed by a protected person; and includes an order that prohibits possession of firearms, ammunition, or a license to carry. For a temporary ex parte order entered pursuant to Chapter 83, the applicable order includes a finding there is a clear and present danger of family violence.

For a protective order entered pursuant to Chapter 85, the order is an agreed protective order, or includes a finding family violence has occurred and is likely to occur in the future.

**IT IS THEREFORE ORDERED** that Respondent prove compliance with the Order prohibiting possession of firearms and ammunition or suspending a license to carry as follows:

1. If Respondent is NOT in possession of firearms, ammunition or a license to carry:
  - a. No later than **THREE DAYS** after Respondent receives notice and a copy of this Order, Respondent shall file a sworn *Proof of Compliance* with the Court certifying Respondent is in compliance by nonpossession of prohibited items.
2. If Respondent IS in possession of firearms, ammunition or a license to carry:
  - a.  **THE COURT FINDS** Respondent is in possession, care, custody, control or management of the firearms, ammunition or licenses to carry listed in the *Addendum*.



b.  **THE COURT ORDERS** Respondent to temporarily transfer to the law enforcement agency selected below, or to transfer or sell to a Licensed Federal Firearms Dealer if option selected below, all prohibited firearms and ammunition in Respondent's possession, care, custody, control or management and any prohibited license to carry, including those listed in the attached *Addendum* to this order, to:

- Bexar County Sheriff's Office
- San Antonio Police Department
- Other Law Enforcement Agency \_\_\_\_\_, or
- Licensed Federal Firearms Dealer

AND, no later than **THREE DAYS** after Respondent receives notice and a copy of this Order, Respondent shall file a sworn *Proof of Compliance* with the Court certifying Respondent is in compliance by transfer of the prohibited items, and attaching a copy of all receipts of transfer.

BUT IF section 2(c) is ordered below, Respondent may choose option 2(b) or 2(c).

c.  **THE COURT ORDERS THAT**, if Respondent wishes to request a temporary transfer or sale of prohibited firearms, ammunition or license to carry to a third party, then Respondent shall, no later than **THREE DAYS** after Respondent receives notice and a copy of this Order, contact the Clerk of this Court to set a hearing on Respondent's request for the third-party transfer. At or by the hearing on Respondent's request for third-party transfer, the Respondent shall be required to:

- Have the third party appear; and/or
- Ensure the third party has filed an affidavit verifying they do not reside with the Respondent, that they passed a federal firearm background check, and that they will not, under any circumstances, provide the Respondent with possession, care, custody control or management of the transferred prohibited items; and/or
- Produce third party's federal firearm background check documentation.
